- + Dumpster update, a new dumpster is in place. It is the same size, just easier to operate. Reminder that no large items are to be placed in or around the dumpster, please contact Bonnie if you have something large to dispose of, she can put you in touch with the garbage company. Fish remains in the freezer go to the trash bin Wednesday night. Replacement of one freezer was approved with a 200.00 budget cap.

+ **Dock placement and partners** remain the same as established last season, placement and spacing to be managed so that all owners have ample space for access.

NEW Business:

- + Leaf removal went well fall 2023, and will be completed spring 2024 as soon as the company is able. Cost for fall and spring leaf removal was \$1450.00
- Lake weed spray/application 2024 is underway. DNR application was filed,
 the company will bill when application is complete.
- + Nominations for three board members will be taken through the summer season with a deadline of July 15th. Bart Schultz (president) Patty Herzberg (board member) and Dan Kolles (board member) are up for reelection or replacement. Nominations may be sent to the secretary via postal mail or on our facebook page.
- + Patty Herzberg encourages all owners to become members of the larger Big Swan Lake Association. Annual dues are 35.00 per year, with continued work they do to maintain our lake and fish quality.

Reminders:

- Kids are to keep OFF of the retaining walls, and are not allowed on privately owned property in the absence of the owner

- Vehicle speed limits, especially along lake shore; keeps dust under control. Make sure your guests as well as yourself adhere.

- + NO additional campers are allowed on ANY common grounds. If you have guests they must be housed on your private property, no exceptions. Tents are fine, as long as they are on your lot.
